Debbie Jones is a Managing Director and Head of Sustainability and Data Innovation for Company Research at Deutsche Bank. Since 2021, she has been responsible for integrating sustainability analysis into the bank's global research product. She is also a member of the Research Exco Committee. Prior to her current role, she served as the lead Paper and Packaging analyst and was recognized by Institutional Investor magazine from 2016. She has been part of the Deutsche Bank Research team since 2005 after obtaining her MBA from New York University (Stern) and BA from Claremont McKenna College with a dual major in Psychology and Economics.

Marion Laboure is a Senior Economist at Deutsche Bank in London and Lecturer at Harvard University. She has extensive private sector, public policy, and monetary policy experience, including at the European Commission, the IMF, the Luxembourg Central Bank, and Barclays. She received first prize from the American Society of Actuaries, Revue Banque nominated her as a rising star in finance, she is part of the 45 standout women in fintech, and Business Insider named her a cryptocurrency mastermind. She is the author of Democratising Finance published by Harvard University Press.

Emily Kreps is Global Head of ESG and Sustainable Finance for the Investment Bank, Origination and Advisory, and Head of ESG for the Americas region. She focuses on ESG strategy, content generation, internal stakeholder management and client engagement, in partnership with our client coverage teams. Emily previously led the Global Capital Markets team at CDP and brings more than a decade of experience as an investment banker, formerly at Goldman Sachs and Credit Suisse.

Stephen Fisher is responsible for leading Deutsche Bank's engagement on regulatory policy and geopolitics, in the Bank's home markets of Germany and the EU, as well as globally. He has over two decades of regulatory policy experience, most recently at BlackRock where he spent 13 years as a senior member of the Global Public Policy Group, based in Brussels and London. Prior to BlackRock, Stephen has worked for seven years in trade associations representing European banks and in the public sector in the UK for the then newly created Financial Services Authority (now Financial Conduct Authority) and HM Treasury.
